You may also submit an Information Statement, no larger than 8 ½ inches by 11 inches, containing your qualifications and/or platform for office. This Information Statement must be submitted to the Association on or before **Wednesday**, **September 27**<sup>th</sup>, **2023**, thirty-five (35) days prior to the scheduled election.

The Information Statement and ballots will be mailed to voting members on or before Wednesday, October 18<sup>th</sup>, 2023, at least fourteen (14) days prior to the date of the Annual Meeting and Election.
